Overview

Through a business alliance with SBI Japan SSI, our company have begun handling the collection of home contents insurance premiums from December 4, 2023, to prevent the risk of not signing up for insurance and the risk of non-payment of insurance premiums by tenants and we have contributed to the peace of mind of tenants and landlords and to improved convenience for property management companies.

Furthermore, by starting API collaboration with SBI Japan SSI’s insurance application management system “Nico,” tenant information and property information when applying for rent guarantee will be linked to home contents insurance application data in a timely manner. Property management companies and tenants no longer need to enter duplicate information and can now complete everything from applying for home insurance to signing a contract in one place, significantly reducing the time and effort involved in signing a home insurance contract.

Going forward, SBI Japan SSI and Casa will continue to create sales opportunities by leveraging our mutual agency networks and aim to further expand profits.
